Every business has a statutory obligation to carry out assessments of the risks that are present in its workplace and to review these risks periodically.


Safety legislation requires that the assessment is carried out by a "competent person" and that all areas of your business activities are assessed in order to:

- Identify who may be harmed
- Evaluate what steps are required to eliminate or minimise the risks

#### Fire Risk Assessment

Every year, fire costs UK companies millions of pounds, from damage to property, loss of business, litigation, fines, compensation claims and increased insurance premiums. It can be the end for small businesses, although many fires can be avoided by taking fire precautions.

As a result of the Regulatory Reform (Fire Safety) Order 2005, fire certificates will no longer be required and employers will have a legal obligation to carry out fire risk assessments of their premises in order to identify requirements and implement procedures.

### Working At Height Assessment

The Work at Height Regulations 2005 place a duty on employers, the self-employed and any person who controls the work of others to do all that is reasonably practicable to avoid, prevent and reduce the consequences of anyone from falling. This now applies to all industries, not just construction, and covers work at any height above and below ground level, including window cleaning, plant maintenance, changing light bulbs in an office and stacking shelves in a store.


### Asbestos Awareness Training Course


The Disability Discrimination Act (DDA) applies to all employers and everyone who provides access, services or goods to the public.


### Workplace Risk Assessor Training Course

# Manual Handling Training Course





#### **Case Studies and Prosecutions**

#### Fall from Height

A leading hospitality group was fined £400,000 after a guest fell from a window which was missing a restricting mechanism at one of its hotels. The group pleaded guilty to breaches of its duties under the Health and Safety at Work etc Act 1974 (s3) by failing to have an adequate risk assessment in place and for not ensuring that staff were given adequate training on checking the safety of the windows.

#### Fire Safety

A major retailer has been fined £3,185 including costs for breaching the Health and Safety at Work etc Act 1974 (s3) for failing to implement an adequate system of fire safety management after council officials visiting one of its stores discovered that emergency exits were obstructed.

#### Fall from Height

A data management company has been fined £40,000 after a worker suffered crushed vertebrae and a fractured pelvis following a 3.5 metres fall from a temporary platform. The company was fined after it was found that the worker was removing boxes from high shelves in the warehouse without any effective fall prevention measures. A safe means of access such as tower scaffold or cherry picker as well as appropriate training should have been provided for the task.

#### Asbestos

An egg carton manufacturer was fined £50,000 and ordered to pay £86,000 prosecution costs after high levels of asbestos were found on its premises. The main source of contamination was found to be from damaged and poorly maintained asbestos insulation.
